Booking & Payment Terms

Deposit

- Payment is required upfront in advance of the retreat.
- A 25% discount code is available to redeem against Shared cabins only before the 31st March 2025.
- Coupon codes can not be used in conjunction with one another.
- WTMG obtain the right to introduce or withdraw discount coupons and offers in line with stated terms. This will not effect any purchases made.
- A non-refundable deposit option is available of 25% PP of the total retreat cost is required to secure your booking for shared cabin accommodation.
- Your place is confirmed only upon receipt of the deposit payment

Final Payment

- Full outstanding balance must be paid by 15th August 2026- Deposit payments.
- Failure to pay by this date may result in forfeiture of your deposit and cancellation of your booking

Cancellation Policy

By You

- All deposits are non-refundable under any circumstances
- Cancellations made after deposit payment will result in loss of deposit
- Cancellations made after final payment will result in loss of all fees paid
- If cancelling your place a non refundable balance of 25% will be retained by WTMG for loss/damages

- Cancellations made under 4 weeks from the event will be charged in full.
- Tickets are non exchangable unless agreed with the proprietor (WTMG) under mitigating circumstances where another person will be supported to take your place- we reserve the right to deny this.
- We strongly recommend purchasing comprehensive travel insurance to protect against unforeseen circumstances

By Us

- We reserve the right to cancel the retreat due to insufficient bookings or circumstances beyond our control
- In the event of cancellation by us, you will receive a full refund of all payments made or the option to transfer to an alternative date

Accommodation

- Shared cabin accommodation is assigned basis of you knowing each other. You will not be asked to share with someone else you don't know.
- For this event you can secure your own accommodation choice
- All participants must respect the shared nature of accommodation and be considerate of fellow guests

Health & Safety

Medical Disclosure

- Participation in activities is at your own risk
- Risk Assessments are completed for all activities and delivered by trained/qualified practitioners and facilitators.

- We are not responsible for any medical costs incurred during the retreat
